**REGULATIONS FOR STUDENT DRIVERS**

*Valid only for the 2021-2022 school year*

I, \_\_\_\_\_, affirm that I am qualified and licensed to operate motor vehicles in New York State pursuant to Motor Vehicle Law and Regulations.

I understand that Sec. 1670 of the Vehicle and Traffic Law authorizes school districts to regulate, restrict or prohibit parking or standing, and to regulate the direction and speed of traffic and otherwise to regulate, restrict or prohibit the movement of motor traffic on any parking fields, driveways, or public ways accessory to any school, playground or facility under the jurisdiction of the school district. Under the law, a violation of any such rule or regulation will be a traffic infraction subject to full penalty of the law.

I further realize that being permitted to drive a vehicle on school property constitutes a privilege, which I may be entitled to only if I obey all vehicular laws and regulations in addition to the following Salem Central School regulations:

- **Students may only park in the student lot, across from the tennis courts, on a first come, first served basis. Students are not allowed to park on East Broadway, Warren St., the high school circle, the paved employee lot by the primary building/playground area, or the dirt lot by the bus garage.**
- Cars will be parked only in designated student parking area. Numbered parking spots will not be assigned; parking spots in designated areas are available on a daily first come, first served basis.
- 
- Parking tag must be displayed in vehicle while on campus.
- No student is to enter any vehicle during the school hours of 8:00 - 2:25 unless authorized to do so. Authorization must be obtained from the high school principal.
- Vehicular speed on school property must never exceed 10 miles per hour.
- Vehicles may not pass occupied buses on school property.
- **BUSES WILL ALWAYS HAVE THE RIGHT OF WAY.**
- Vehicles must first stop when executing turns into areas where vision is partially or completely obstructed.
- I understand that by signing and registering my vehicle to be parked on school property, that school officials may search the vehicle with reasonable suspicion of violating the law or school rules and/or law enforcement officials may search said vehicle for contraband with probable cause.
- Seniors are given priority to apply for parking privileges, then juniors, and then sophomores.

I promise to comply with the foregoing rules and regulations at all time when driving on school property. I fully understand my responsibility as a driver and citizen of Salem Central School. I further realize that any improper driving conduct on my part will result in any or all of the following: a traffic summons, suspension, revocation of my driving privileges, and/or additional disciplinary consequences per the disciplinary code.
